The board members of any organization - incorporated or not - for profit or non-profit - have a legal duty of care under common law for the safety of their workers, whether they be employees or volunteers. This duty of care is higher when the activities of the organization involve a greater degree of risk whether because of the type of activity or the location, outside of Canada. Failure to meet that duty of care can result in lawsuits against both the organization and its board members. Common law precedents in past court settlements and liability awards reinforce that this duty of care is even more heightened when travel includes youth participants.

Bill C-45

Federal workplace safety legislation, also know as the "Westray Bill", first passed in 2004. Amendments to the law have extended the concept of the "workplace" beyond the four walls of a physical location, clarified "employer" organizations to include associations of persons and expanded the definition of "work" to include tasks. This law can make the directors of charities and not-for-profits subject to criminal prosecution, fines and penalties if they or other leaders are guilty of gross negligence in contributing to injury, disease or fatalities suffered by anyone carrying out the organization's work on premises, off-premises or anywhere in the world, whether they be employees or volunteers.

"217.1 Every one who undertakes, or has the authority, to direct how another person does work or performs a task is under a legal duty to take reasonable steps to prevent bodily harm to that person, or any other person, arising from that work or task."

Note: It does not pay for ransom sums and it does not cover incidents in countries or regions where the Canadian government has issued a warning to AVOID ALL TRAVEL at the time the person entered that country or region.

Kidnap and Ransom and Extortion Insurance [OPTIONAL]

A comprehensive special risk insurance product through Lloyds of London used by thousands of non-governmental organizations, churches and religious charities who send staff and short term mission teams to areas around the world prone to a higher degree of risk for kidnapping and abduction. K&R coverage provides "up-front" assistance and consulting services to assist in determining proof of life and locating kidnapped persons, as well as for negotiation, extraction and paying ransom up to the limit of the policy. Coverage limits can be purchased up to \$5,000,000 for any one incident.
